Information regarding the processing of personal data

In accordance with Article 13 of the Regulation 2016/679 of the European Parliament and of the (EU) Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as GDPR), the administrator provides the required information related to the processing of your personal data.

- 1. The administrator of personal data is the Warsaw Rising Museum located at 79 Grzybowska Street, 00-844 Warsaw (hereinafter referred to as the administrator).
- 2. The administrator has appointed a Data Protection Officer who can be contacted by writing to the administrator's postal address or by email at iod@1944.pl. The Data Protection Officer is responsible for matters related to the processing of data, including the exercise of rights.
- 3. Personal data will be processed by the administrator for the purpose of organizing the "Roots of Memory" project, which aims to disseminate knowledge and cultivate the memory of the Warsaw Rising and its participants. This includes:
 - (1) Acceptance and verification of submissions based on the provided consent, which involves completing the questionnaire of a family member of a Warsaw Insurgent, entering all necessary data, and submitting it to the Warsaw Rising Museum (Article 6(1)(a) of the GDPR).
 - (2) Contact (regarding questionnaire-related matters), including correspondence based on the administrator's legitimate interest in contacting for possible clarification of information present in the submitted questionnaire (Article 6(1)(f) of the GDPR).
 - (3) Contact and representation of a minor by their legal representative, due to the administrator's legitimate interest in the necessity of contacting the legal representative of a minor in connection with participation in the project (Article 6(1)(f) of the GDPR).
 - (4) Informing about events organized by the administrator and inviting to ceremonies based on the granted consent for the processing of personal data (Article 6(1)(a) of the GDPR).
 - (5) art. 6 ust. 1 lit. e) RODO); Carrying out statutory activities of the administrator, including the preparation and organization of events aimed at cultivating the memory of the Warsaw Rising. This processing is necessary for the performance of a task carried out in the public interest (Article 6(1)(e) of the GDPR). Implementation of statutory activities by the administrator, including, among others, the preparation and organization of events aimed at cultivating the memory of the Warsaw Rising. In the case in which this processing is necessary for the performance of a task carried out in the public interest, which involves undertaking activities in the implementation of statutory tasks, organizing ceremonies of national and state, diplomatic, social, scientific, artistic, and cultural significance, contributing to shaping the image of Poland, and conducting activities related to integrating veteran and military communities (Article 6(1)(e) of the GDPR).
 - (6) Defense against potential claims or the pursuit of claims based on the administrator's legitimate interest, which is documenting and storing information to pursue, establish, or defend against potential claims (Article 6(1)(f) of the GDPR).

- (7) Archival and accountability purposes based on the necessity to fulfill a legal obligation imposed by applicable laws (Article 6(1)(c) of the GDPR) and the administrator's legitimate interest in demonstrating compliance with applicable laws (Article 6(1)(f) of the GDPR).
- 4. The anticipated recipients of your personal data are entities providing IT, courier, and postal services.
- 5. Your personal data will be stored for a period necessary to achieve the above-mentioned purposes, but no longer than the withdrawal of consent. In the case of personal data whose processing is necessary for purposes arising from the administrator's legitimate interests, they will be stored no longer than the effective date of objection to the processing of personal data. If there are valid legal grounds for processing data or grounds for asserting or defending claims, the data will be stored until the end of the period for asserting or defending claims by the administrator and the expiration of the document retention period required by applicable laws.
- 6. You have the right to request access to your personal data, their correction, deletion, or limitation of processing from the administrator. In the case of processing personal data based on Article 6(1)(e) or (f) of the GDPR, you have the right to object at any time for reasons related to your particular situation to the processing of your personal data.
- 7. In the case of processing personal data based on consent under Article 6(1)(a) of the GDPR, you have the right to withdraw your consent at any time without affecting the lawfulness of the processing carried out based on the consent before its withdrawal.
- 8. You have the right to lodge a complaint with the supervisory authority, i.e., the President of the Office for Personal Data Protection (ul. Stawki 2, 00-193 Warsaw).
- 9. Providing personal data is necessary to submit an application. Providing data for the purpose of receiving information about events organized by the administrator is voluntary but necessary if one wishes to receive information about events organized by the administrator in the future.
- 10. During the processing of personal data, there will be no automated decision-making, and profiling will not be applied.
